<b>Playschool Policies</b>	<b>Initial</b>
<u>I understand that I must come to my volunteer commitment and that if I am unable to attend I must provide a suitable replacement. I understand if I do not show up the day of my commitment without prior arrangements my cheque will be cashed the day of the missed commitment and will not be refundable.</u>	
I understand that Fraser Community League will allow for withdrawal from the program at any time, but after November 1 the Volunteer Commitments must be completed even if you withdraw. I understand that the community league membership, and field trip fee are nonrefundable.	
I agree to allow Fraser Community League to photograph my child and to use them in marketing and social media. Fraser Community League will only use photos in relation to advertising the Playschool and will make every attempt to obscure children's faces and identifying features.	
I understand that I may be asked to leave during any school session if I am deemed to be acting inappropriately or putting any other person in danger, at the discretion of the Lead Teacher.	
I agree to follow all COVID-19 safety procedures put in place by Fraser Community League/City of Edmonton, and understand failure to do so may result in my child's removal from the program.	
On admission of my child to Fraser playschool, I agree to comply with the rules and regulations, and to cooperate fully with requirements of the program, with the understanding that my child be well cared for and supervise while attending Fraser playschool	
I understand that my child must be a minimum of three years old prior to the first class. I agree that my child is toilet trained, and that failure to do so will result in my child being withdrawn from the program.	
I understand the Fraser Community League will be responsible for obtaining liability insurance for accidents which may occur while my child is in their care.	
In the event of an emergency, I give permission for medical treatment to be obtained for my child. Any cost such as an ambulance will be paid by me.	
I agree to not have my child at the playschool any earlier than 8:50 AM and then I will pick my child up promptly after class at 11:30. If there are issues pertaining to prompt pick up I understand this may result in the withdrawal of my child from the program. I agree to ensure that my child is dressed appropriately, and will wear clothing that can be used in regular day-to-day activity at the play school (this includes painting,gluing, cutting). I also agree to label all the clothing that I pack with my child or in their backpacks. My child will require indoor shoes, a backpack, and a lunch kit.	
<b>Child Discipline Policy</b>	
Fraser Playschool will ensure that child discipline methods utilized in the program are communicated to parents and staff, and any child disciplinary action taken is reasonable in the circumstances.	
Fraser Playschool <b>will not</b> , with respect to a child in the program <ol style="list-style-type: none"> <li>1. Inflict or caused to be inflicted any form of physical punishment, verbal, or physical degradation, or emotional</li> </ol>

<p><b>Outdoor Activity Permission Form</b></p> <p>I give permission for my child to attend occasional outside activities on the Fraser community grounds surrounding the playschool (example playing at the park, rinks, short walks, outside games with weather permitting). This is separate from scheduled field trips were a separate permission slip will be sent home</p>	
<p><b>Health Care Policy</b></p> <p>in the event of a serious illness or an accident involving a child - while said child is attending Fraser Playschool, the staff will ensure that the child's parent is notified immediately, and the child receives medical attention in the form of first aid. In the event of an emergency, staff will call 911 and proceed as directed.</p>
